Preface

The revision of the National Competency for Licensed Nurses in Lao PDR in 2021 was carried out by the nursing and midwifery board in collaboration with the Project for Sustainable Development and Quality Assurance of Healthcare Professionals by JICA, partially supported by UNFPA technical assistance. The objective was to improve the nursing competency in Lao PDR and demonstrate nursing service delivery to serve the people or clients within ASEAN and internationally.

The goal of revising the nursing competency focuses on the development of nurses to express themselves in three aspects of nursing practice: 1. Cognitive Domain, 2. Affective Domain, and 3. Psychomotor Domain, which nursing and midwifery board has defined the core competencies that are in line with the five core domains of ASEAN Nursing: 1) Professional, Legal, and Ethical Nursing Practice; 2) Professional Nursing Practice; 3) Leadership and Nursing Management, 4) Nursing Research, and 5) Professional Nursing and Personal Development.

The nursing and midwifery board expects Lao nurses need to improve their nursing competency and utilize this competency framework in their daily practice for personal development. Licensed nurses obtain competency to provide healthcare services effectively and efficiently during the era of social and cultural change. Therefore, professional nursing services will be recognized for their higher value in the health system.

The Nursing and Midwifery Board

Background of revising the National Competencies for Licensed Nurses in Lao PDR

Changes in the economic, social, cultural, environmental, and technological advances affect the health of more complex people. In addition, people of different ethnic groups have different beliefs, customs, and health behaviors. It has long been a practice in health care, affecting the risk of developing acute respiratory infections (Covid-19) prevalent worldwide. At the same time, chronic disease (non-communicable disease) is a silent disease that causes illness and death as a challenge in prevention and control. Medical services sometimes carry a high risk of infection. Nurses faced difficulties treating diseased infectious cases. Therefore, there is a need to develop the capacity of nurses as well.

Nurses play an essential role in the health care system in Lao PDR. They are actively involved in improving the quality of public health services by implementing the five good and 1 Satisfaction Policies of the Ministry of Health.

Nursing is one of the seven professions under the ASEAN Mutual Recognition Arrangement, promoting service cooperation among ASEAN member countries. To improve efficiency and competitiveness, diversify production capabilities to supply and expand services to consumers within and outside ASEAN. To remove barriers to services between ASEAN member states, accept ASEAN as a free professional nurse. In each ASEAN member state, there is a need to improve laws, regulations, ethics, professionalism, and licensed nurses' level of education to be minimum of three years. Therefore, the Ministry of Health developed "National competency for licensed nurses" in 2013, which defined the framework and mechanism for monitoring, promoting, and managing the quality of licensed nurses. So nurses will be able to provide higher quality health care for the people.

Through the application and evaluation of licensed nursing competencies, most nurses still have limited knowledge, skills, attitudes, leadership, analytical thinking, research, innovation, and motivation in providing a nursing service, and professional value promotion. Furthermore, the competencies contents are not aligned with the ASEAN structure as communication, risk management, research, and ongoing nursing professional development.

The ASEAN Mutual Recognition Arrangement on Nursing service was signed on December 8, 2005, on the transfer of qualified individuals only in accordance with the standards outlined in the MRA (commencing in 2015), which aims to strengthen the capacity of professionals by promoting the exchange of knowledge, experts and/or expertise on standard and qualification according to the needs of the member countries. Therefore, the nursing and midwifery board had to revise the nursing competency by 2021 to guide nurses. Thus, the nurses will be able to develop themselves to a higher level, to be able to contribute nursing services, meet the needs of different and multicultural clients, both within ASEAN and internationally, keep abreast of the changing nature of the system, and use this capacity to improve the nursing education curriculum in line with ASEAN professional nursing competency.

Purpose

The purpose of applying the National Competency for Licensed Nurses is to ensure the knowledge, skills, and attitudes of professional nurses in Laos using the following:

- 1. Guide in reviewing and developing the nursing curriculum,
- 2. Guide competency development and assessment of students and newly graduated nurses,
- 3. Assess the competencies of internationally qualified nurses seeking employment in Laos,
- 4. Evaluate the performance of the professional nurses.

Goal

The goal of development of National Competency for Licensed Nurses are:

- 1. To define core competency domains, competency standards, and competency indicators. These elements guide competencies-development to provide professional nursing services for the population within the country, ASEAN, and international level,
- 2. To define competency level according to the years of experience among professional nurses in the hospitals and the community,
- 3. To define behavioral indicators at each competency level to help coordinate, manage, and measure performance in developing the nursing profession.

Creation process

- 1. The nursing and midwifery board was appointed to revise the national competency for licensed nurses. Board members allocated the responsibilities.
- 2. Reviewed the version developed in 2013 and studied ASEAN and international nursing competency framework.
- 3. Compared the first version in 2013 with ASEAN and international standards and followed the ASEAN core competency framework.
- 4. Drafted nursing competency revised version 2021.
- 5. Commented on the draft content and approved competency for nurses in Lao PDR in the validation meeting.

Conclusion

The revised national competency for licensed nurses in Lao PDR 2021 consists of 2 sections. Part 1 defines the domains of core competency in line with ASEAN's five core domains, such as:

Domain 1) Professional, Legal and Ethical Nursing Practice,

Domain 2) Professional Nursing Practice,

Domain 3) Leadership and Nursing Management,

Domain 4) Nursing Research

Domain 5) Professional and Personal development

Part 2 defines four competency level as follow:

Level 1: Beginners who follow the instructions or advice of an experienced nurse

Level 2: Advanced who experience 1-2 years of clinical experience

Level 3: Competent who experiences 3-4 years of clinical experience

Level 4: Expert or specialist who experienced more than five years' clinical experience

Glossary of Terms

Competency: possession of knowledge, skill, and attitudes as a professional nurse in order to perform a set of defined activities to an expected scope of the nursing practice and the nursing practice standard.

Competent Nurse: nurses who have obtained a professional nursing license can apply knowledge, skills, and attitudes to performe for that level and can evaluate within the scope of nursing.

Core competency domain: a standard set of performance domains and their corresponding behavioral elements which a nurse is required to demonstrate.

Competency standard: practice standard and behavior of nurses expressed in accordance with core competencies.

Competency statement: behaviors that require the nurse to express themselves in accordance with their abilities and core competencies.

Competency indicator: indicators that nurses demonstrate while providing nursing services and can be used to assess competency.

Competency level: the level of nurses experienced while providing health nursing services according to Benner's theory on novice to expert (1984)

Part II. Lao nursing professional competency level

Lao professional nursing competency level refer to the level of the nurse expressed while providing nursing care services as specified in Benner's stage of clinical competence (1984). There are 4 levels as follows:



Level 1: Interns (beginner) or novice included the high diploma and Bachelor's Degree nursing following basic nursing care procedures and practicing nursing with needed advice from experience nurses.

Level 2: Advanced interns next to advance beginner 1-2 years. Nurses who have an initial professional license will starts training a nurse professional for 1 year to obtain a full license, can prioritize critical care if the difficult case is to consult with the experience to decide to take appropriate care.

Level 3: A person who has ability to implement the nursing care (competent 3-4 years), is able provide a difficult healthcare but still lacking professional and specialist skill as well as the ability to deal with hesitation while performing the task.

Level 4: A person who has ability of nursing care competent more than five years' experience of clinical practice, specialize on problem analysis, as a consultant and consideration of problem-solving options and providing standardized health care to meet the right health care needs.

Defining the content of nursing professional Competencies levels 1-4 is described in accordance with the competencies, core competencies and competencies that can be assessed, as detailed in the table below:
